

Non-Psychotropic Cannabinoid Is "Safe," "Well Tolerated" In Humans, Study Says

"CBD is non-toxic ... and does not alter psychomotor or psychological functions"

Brazil: Sao Paulo, The the administration of nonpsychotropic cannabis plant constituent cannabidiol (CBD) is "non-toxic" to healthy cells and is "well tolerated" humans. in according to review data published online in the scientific journal Current Drug Safety.

Investigators at the University of Sao Paulo, Clinical Hospital reviewed over 130 papers assessing the impact of CBD in humans and animals. Studies describing the effects of multiple cannabinoids or CBD extracts were excluded from the analysis.

Authors reported: "Several studies suggest that CBD is well tolerated and safe in humans at high doses and with chronic use. ... [S]tudies suggest that CBD is non-toxic in non-transformed cells and does not induce changes on food intake, does not induce catalepsy [muscular rigidity], does affect physiological parameters (heart rate, blood pressure and body temperature), does not affect gastrointestinal transit and does not psychomotor or psychological functions."

They concluded, "Based on recent advances in cannabinoid administration in humans, controlled CBD may be safe in humans and animals. However,

Hospice Health Professionals Support Legalization Of Cannabis For Therapeutic Use

Philadelphia, PA, USA: A majority of hospice health professionals favor allowing the legally regulated use of cannabis for terminally ill patients, according to <u>survey data</u> published online in the *Journal of Palliative Medicine*.

Investigators at the University of Pennsylvania utilized a 16-item questionnaire to assess the knowledge, experience, and views of hospice professionals regarding the use of marijuana in terminally



Separate investigations of CBD have documented the cannabinoid to possess a variety of therapeutic properties, including anti-inflammatory, anti-

diabetic, anti-epileptic, anti-cancer, and bone-stimulating properties. In recent years, patients in states that allow for the use of cannabis therapy, particularly California,



have <u>expressed an interest</u> in plant <u>strains</u> that contain uniquely high percentages of the compound.

Cannabidiol is presently classified under federal law as a <u>schedule I</u> prohibited substance. Such substances are required by law to possess "a high potential for abuse," "a lack of accepted safety ... under medical supervision," and "no currently accepted medical use in treatment in the United States."

<continued from BI-PARTISAN GROUP OF GOVERNORS CALL ON PRESIDENT OBAMA TO RE-SCHEDULE MARIJUANA, page 1 > Vermont have petitioned the federal government to reschedule marijuana under the federal Controlled Substances Act from Schedule I to Schedule II, which would permit the drug to be prescribed by physicians as a medicine.

"What we have here on the ground is chaos," said Governor Gregoire., adding that patients "who ... either feel like they're criminals or may be engaged in some criminal activity, and really are legitimate patients who want medical marijuana."

Connecticut Democrat Governor Daniel Malloy has said he will also be joining the group of governors petitioning the federal government.

Democrat Governor John Hickenlooper of Colorado has announced that he will be making a similar request to the Obama administration prior to January 1, 2012, as required by state law.

Rescheduling marijuana to a lower schedule under federal law would not authorize medical marijuana dispensaries, such as those that exist under state law in California, Colorado, New Mexico and Maine, and that have been authorized in a handful of additional states, but it would begin the process of making marijuana available from licensed pharmacists. Authors concluded, "The study results revealed that, like the general public, hospice health care providers are generally in favor of legalization of marijuana and, if legalized, would support its use in symptom management for their terminally ill patients."

Various <u>health professional organizations</u>, including the American Nurses Association and the American Public Health Association, have enacted resolutions in support of allowing patients the legal alternative to use cannabis therapy. <continued from CALIFORNIA: STATE LAWMAKER MEETS WITH US ATTORNEY REGARDING FEDERAL CRACKDOWN ON CANNABIS PROVIDERS, page 1 > Ammiano said that the meeting with Haag -- who describes cannabis dispensaries as "magnet(s) for crime" and alleges that they "send the wrong message to those in our society who are the most impressionable" -- did "not result in any (policy) changes."

According to a <u>report</u> in the <u>San Francisco Bay Guardian</u>, Haag offered no specifics at the meeting regarding what actions state lawmakers could take to regulate dispensaries in a manner that would not instigate federal intervention or prosecution. In 2009, Ammiano sponsored legislation to legalize and regulate the commercial production and sale of cannabis for adults age 21 or over. State lawmakers are believed to be considering <u>legislation</u> in 2012 that would seek to more strictly regulate the state's medical cannabis industry.

Last month, members of the NORML Legal Committee, led by Matt Kumin and David Michael from San Francisco and Alan Silber from Roseland, NJ, <u>filed suit</u> against the federal government in an effort to halt the Obama administration's ongoing crackdown on California's medical cannabis producers and providers. Colorado: Justice Department Threatens To Target State-Licensed Cannabis Facilities

Denver, CO, USA: United States Justice Department officials are planning to target the operators of several of the state's licensed cannabis facilities, according to a CBS Denver News report broadcast last week.

According to the report, Justice Department officials will be targeting facilities alleged to be located within 1,000 feet of schools, regardless of whether the operations are properly licensed by the state, which does not mandate such zoning restrictions.

"Dispensaries that receive the letters will be given 45 days to shut down or move operations. If they

don't comply, they will be shut down by the US attorney in Colorado."

Since 2010, state officials have <u>explicitly licensed</u> cultivators and dispensers of cannabis for therapeutic purposes. At least <u>700</u> state-licensed cannabis dispensaries are presently operating in the state.

The federal threat appears to be inconsistent with statements made by US Attorney General Eric Holder before Congress just one week earlier when he told House Rep. Jared Polis (D-CO) that it "would not be a priority" for federal officials to take actions against "people (who) are acting in conformity with the (state's) law."

In October, United States Deputy Attorney General James Cole, along with the four US Attorneys from California, announced their <u>intentions</u> to escalate federal efforts targeting the state's medical cannabis dispensaries and providers. Since that time, Justice Department officials have also spearheaded separate actions targeting medical cannabis operations in Montana and <u>Washington</u>.

Study: Inhaled Cannabis Modulates Appetite Hormones In HIV Patients

San Diego, CA, USA: Cannabis inhalation is associated with increased levels of appetite hormones in the blood of subjects with HIV infection, according to clinical trial <u>data</u> published online in the scientific journal *Brain Research*.

Investigators at the University of California, San

Diego and the Center for Medicinal Cannabis
Research assessed the effects of inhaled cannabis on the appetite hormones ghrelin, leptin and peptide YY (PYY), as well as insulin, in adult subjects with HIV.



Insulin, ghrelin, PYY, and leptin are hormones individually modulated in response to food intake and energy homeostasis.

Researchers reported: "Compared to placebo, cannabis administration was associated with significant increases in plasma levels of ghrelin and

<continued from previous page> leptin, and decreases in PYY, but did not significantly influence insulin levels. ... Cannabis-related changes in these hormones had a magnitude similar to what has been observed with food intake over the course of a day in normal volunteers, suggesting physiological relevance."

They concluded, "These findings support further evaluations of interventions directed at manipulating the <u>endocannabinoid system</u> for the treatment of eating disorders and obesity."

Cannabis Beneficial To Patients With Inflammatory Bowel Disease

"Inhaled cannabis improves quality of life measurements, disease activity index, and causes weight gain"

Aviv, **Israel:** The inhalation of cannabis increases quality of life, mitigates disease activity, and promotes weight gain in subjects with inflammatory bowel disease (IBD), according to clinical trial data online published in the scientific journal Digestion.



Investigators at the Chaim Sheba Medical Center in Tel Aviv, Israel assessed the efficacy of inhaled prescription cannabis in patients with long-standing IBD, such as Crohn's disease.

Researchers reported: "After three months' treatment, patients reported improvement in general health perception, social functioning, ability to work, physical pain and depression. A schematic scale of health perception showed an improved score. ... Patients had ... weight gain ... during treatment and an average rise in BMI (body mass index)."

They concluded, "Three months' treatment with inhaled cannabis improves quality of life measurements, disease activity index, and causes weight gain and rise in BMI in long-standing IBD patients."

An estimated 6,000 Israelis <u>are supplied</u> with locally grown cannabis for therapeutic purposes as part of a limited government program.

<u>Survey data</u> published in August in the <u>European Journal</u> of <u>Gastroenterology and Hepatology reported</u> that an estimated one-third of patients with colitis and one-half of subjects with Crohn's acknowledge having used cannabis to <u>mitigate their disease symptoms</u>.

Most recently, clinical trial data published in September in the *Journal of the Israeli Medical Association* reported that the use of cannabis is associated with a reduction in Crohn's disease activity and disease-related surgeries.

Researchers at the Meir Medical Center in Israel are presently evaluating the safety and efficacy of inhaled cannabis for patients with Crohn's and Ulcerative Colitis in a double-blind, placebocontrolled trial, according to a summary of the US federal government website clinicaltrials.gov. Federal Agency Recognizes Cannabis Fights Cancer

In March, an agency of the U.S. federal government for the first time acknowledged that cannabis has been shown to fight cancer, and said health care providers may recommend it for that purpose. But after five days of media attention, the National Cancer Institute removed from its website any mention that cannabis may be used to combat tumors.

The NCI originally said that "the health care provider may recommend medicinal Cannabis not only for symptom management but also for its possible direct antitumor effect." That directly contradicts the federal government's oft-repeated contention that cannabis has no medical use.

The NCI website still notes that "cannabis has been used for medicinal purposes for thousands of years," and says people living with cancer may find effective for combating stimulating appetite, relieving pain, and improving also classifies cannabis Complementary Alternative Medicine (CAM) and summarizes several decades of research on the potential role of cannabis and its constituent chemicals in cancer treatment.

The antitumor effects of cannabinoids include reducing the spread of cancer cells, selectively cutting off the blood supply to tumors, and reprogramming malignant cells to die Researchers have demonstrated these effects on human cancer lines including skin, breast, bone, liver, adrenal, leukemic and brain cancers. Trio of Medical Cannabis Bills Introduced in Congress

Three bipartisan medical cannabis bills were introduced in Congress in 2011 with support from

<continued from TRIO OF MEDICAL CANNABIS BILLS INTRODUCED IN CONGRESS, previous page> ASA and other patient advocates. The bills would respectively reclassify

cannabis as a drug with medical use, protect access to financial services for patients and providers, and rein in aggressive audits of providers by the IRS.

HR 1983, the State's Medical Marijuana Protection Act of 2011, would provide a medical necessity defense in federal court and reclassify cannabis from a Schedule I substance with no medical use to Schedule III, a level that would allow doctors to prescribe it like

HR 1984, the Small Business Banking Improvement Act of 2011, would allow banks and other financial institutions to provide services to medical marijuana businesses without being subject to "suspicious activity" reporting requirements. Several banks have closed the accounts of medical cannabis providers under pressure from the Department of Treasury.

HR 1985, the Small Business Tax Equity Act of 2011, would change the federal tax code "to allow a deduction for expenses in connection with the trade or business of selling marijuana intended for patients for medical purposes pursuant to State law." The IRS has been aggressively auditing dozens of the most successful medical cannabis dispensing centers, disallowing their operating expense deductions and claiming back taxes.

ASA Builds Grassroots with Trainings and Online Tools

ASA expanded its grassroots support nationwide last year through online activist bootcamps, web-based training tools, an ASA Advocates App, and roaming stakeholder meetings.

In February activists from coast to coast gathered for ASA's first virtual conference, a two-day "Activist Boot Camp" of trainings that combined a more than 300-page workbook of materials with informational DVDs.

Virtual bootcamp participants from Denver to Detroit, Portland to Chicago, Las Vegas to St. Louis, learned about effective outreach, coalition building, leadership development, lobbying public officials, organizing protests and rallies, and working with the media.

ASA also spent the year holding in-person stakeholders' meetings and raid preparedness trainings in Colorado, Michigan, Montana, Nevada, Oregon, and Washington, as well as throughout California.

Facilitated by ASA Executive Director Steph Sherer and California Director Don Duncan, the meetings helped participants share experiences and identify goals, problems and solutions. The raid preparedness trainings gave community members tools and strategies for responding to interference by law enforcement.

In response to ideas generated in the stakeholders' meetings, ASA launched an online initiative to give advocates 24/7 access to lobbying tools, an information center, and tools for rapid response to federal raids.

The <u>Medical Cannabis Think Tank and Policy Shop</u> provides the information and support activists need to analyze pending or proposed legislation and to lobby officials for the best laws possible.

The <u>ASA Online Training Center</u> gives advocates access to all ASA's training and educational materials, including streaming video presentations and comprehensive manuals and worksheets for developing advocacy skills.

ASA also improved its <u>Raid Response Center</u> to better cope with federal interference, including how to prepare for and respond to law enforcement actions.

In December the <u>ASA App</u> launched, putting a full range of ASA tools and information in the hands of advocates through iPhones and iPads. The app will be available on Android this spring.
